GENERAL RULES AND REGULATIONS

IF ANY INSTANCE ARISES THAT WE DO NOT HAVE A RULE SPECIFIC TO THE SITUATION HEREIN, WE MAY REFER TO THE 2024 OKLAHOMA YOUTH EXPO RULES FOR GUIDANCE IN CLARIFYING THE ISSUE.

1. The Canadian County Junior Livestock Show is sponsored by the Canadian County Free Fair Board, Inc., and the supervision of the show will be under their general direction.
2. The Canadian County Free Fair Board reserves the right to interpret these rules and regulations and arbitrarily settle all questions arising in connection with the Show. The management also reserves the right to amend or add to these rules, as they in their judgement deem advisable. In the event of conflict of any of these rules or regulations, the latter will govern.
3. Any person who violates any of the following rules shall forfeit all privileges and premiums and be subject to such penalty as the Show Management may order. All exhibitors and others shall be strictly liable for any violation of the rules contained in this exhibitor handbook. Should any exhibitor who violates the rules in this handbook, want to contest the decision or finding of the Show Management, they will be responsible for all expenses associated with such contest and will also be responsible for all costs and fees incurred by the Show Management due to said actions.
4. The Fair Board has adopted the policy whereby if an exhibitor is barred from showing for unethical practices at a major show, they will also be barred from showing at the County Fair and County Junior Livestock Show. The Fair Board also adheres to the IAFE Code of Show Ring Ethics.
5. Animals must be fed and cared for by the exhibitor to be eligible to show in the Jr. Livestock Show and County Fair. Animals will be subject to random checking as deemed necessary by the Ag. Ed. Instructors and/or Extension Personnel.
6. All exhibitors will be limited to showing three doe goats, three goat wethers, three gilts, three barrows, three ewe lambs, three wethers, three heifers, three prospect steers, three market steers, and one Pen of 3 Broilers.
7. Exhibitors in this show must be bonafide members of a Canadian County 4-H club or FFA chapter, be 8 years of age and in 3rd grade as per OYE guidelines and have not graduated from high school. Exhibitors must also reside in Canadian County and are home schooled and/or attend a school whose district is in Canadian County. In no case will a Junior Livestock Exhibitor and/or entry be eligible to show in more than one county.
8. 4-H members must be enrolled and listed as ACTIVE by February 2 of the year event is held.
9. All exhibits must be bonafide property of the person in whose name the exhibit is entered. Each exhibitor must show exhibitor's own animal unless exhibitor has more than one in a class. Any exception to this rule will require a request written by the exhibitor on the back of exhibitor's entry card, signed by the exhibitor and approved by the General Superintendent.
10. No agent, parent, coaches, or instructors will be allowed in the ring while animals are being judged.
11. All market barrows, market wethers, market wether goats, market steers, commercial ewes, all gilts and all does eligible for County Show and Sale must have been nominated as per Oklahoma Youth Expo guidelines. All exhibitors will have the option at **Weigh-IN** to switch to the Crossbred class. All Broilers must be qualified for SW District Show. All animals exhibited must have been under the personal daily care of the exhibitor for the designated number of days. All ownership requirements follow OYE rules and deadlines. (See chart on page 13 for details.)

12. Grand Champion Market and Breeding winners may compete for Showmanship Award in the livestock division in which he/she won Grand Champion. Individual must be an exhibitor in that particular division to compete for Showmanship Award.
13. The superintendents of the steer, swine, sheep, and goat divisions shall have the authority to check the nomination list to make sure animals are shown as nominated for OYE. Broiler superintendent will check broiler qualifications from the SW District Show. **All animals will be shown by breed based on OYE Nomination and should be entered as such at pre-entry. Exhibitors will have the option at WEIGH-IN to switch to the Crossbred class ONLY.**
14. Dress code for Spring Show and Fall Fair will be as follows:
 Goats, Sheep, and Beef -No color changing agents, adhesives or boning aids allowed. Beef Show will be blow and show only.
 Swine - Water only, no oil, paint or dye
15. Show order for goats will be – **doe goats:** Grand, Reserve Grand and Bronze drive, Alt. selections, **market goats:** Grand, Reserve Grand and Bronze drive. Sale Order lineup, Showmanship contest.
16. Show order for sheep will be - **ewe lambs:** Grand, Reserve Grand, and Bronze drive, Alt. selections, **market wethers:** Grand and Reserve Grand drive, Sale Order lineup, Showmanship contest.
17. Show order for swine will be - **gilts:** Grand, Reserve Grand and Bronze drive, Alt. selections, **market barrows:** Grand and Reserve Grand drive, Sale Order lineup, Showmanship contest.
18. Show order for beef will be - **heifers:** Grand, Reserve Grand and Bronze drive, Alt. selections, **prospect steers:** Grand and Reserve Grand, **market steers:** Grand and Reserve Grand, Sale Order lineup, Showmanship contest.
19. All **Broilers** must have original wing bands properly in place.
20. All exhibitors are asked to keep stalls and pens clean and place litter where designated by superintendents.
21. Each club or chapter will be responsible for tagging their own species with Federal #840 ear tags and OYE ear tags. Tags are required at this Jr. Livestock Show.
22. No dogs or pets, other than handicapped assistance dogs, shall be permitted on the fairgrounds or in exhibit buildings during the Stock show, unless they are part of an authorized act or exhibit.
23. No alcoholic beverages, illegal substances or firearms allowed on the Fairgrounds or Expo Center.

**IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS)
CODE OF SHOW RING ETHICS.**

NOTICE

All Livestock Exhibitors and Parent or Guardian must date and sign the Exhibitor Entry Statement Form for the IAFE Code of Show Ring Ethics.

This signed form will be checked off by a Ag/4-H Teachers during pre-entry by checking yes or no box for the Canadian County Jr. Livestock Show.

Exhibitors of animals at livestock shows shall at all times conduct themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

IAFE Code of Show Ring Ethics

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1) All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- 2) Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- 3) Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4) Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

- 5) Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6) The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- 8) No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
- 9) The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- 10) The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expos and any special notices to members.
- 11) The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

PROTESTS AND APPEALS

- Section 1. All protests must be made in writing and accompanied by a deposit of \$250 which deposit will be forfeited if protest is not sustained. Said protest must state plainly the cause of the complaint or appeal, and must be filed with the Fair Board Secretary within five (5) hours after the award was made, it being considered the award was made when ribbon premium card was placed.
- Section 2. No complaint or appeal based upon the statement that the judge or judges are incompetent or have overlooked an animal or article, will be considered by the management.
- Section 3. The right of an exhibitor to appeal from the decision of a judge to the Board of Directors will apply only when it is charged that the award has been made in violation of the rules governing the exhibit; or when it is charged that the decision of the judge has been influenced or interfered with by another.
- Section 4. Appeals from the decision of a judge or superintendent in charge must be made in writing, and must contain at least one specific charge stating at length the facts relied upon or the rule violated, and having witnesses and their addresses by whom proof is to be made.
- Section 5. All questions or disputes or differences not provided for under the rules shall be referred to the Fair Board of Directors whose decision shall be final.
- Section 6. In addition to the right to protest herein guaranteed to exhibitors, the Fair Board of Directors reserve the right to take cognizance of fraud consummated or attempted in connection with an exhibit and take such action as may be deemed just and proper and as may be warranted in the premises.

ALL PRIZE PREMIUMS WILL BE PAID BY CHECK FROM THE OFFICE OF THE CANADIAN COUNTY FAIR BOARD. EXHIBITORS SHOULD RECEIVE THEM IN ABOUT THREE TO FOUR WEEKS.

4-H ELIGIBILITY



1. 4-H Age Division: determined by the youth's public school grade as of September 1 each year.
2. A child's "grade division" will not change until (re)enrollment in August.
3. Youth may enroll in 4-H on August 1 if they are 8 AND in the 3rd grade on September 1. If they turn 8 after September 1 and are in 3rd grade, they will not be eligible to enroll as a 4-H member until the next 4-H year, but they may participate as a Cloverbud. When a child turns 9, they may join as a 4-H member regardless of grade level. 4-H membership ends on July 31 following the completion of the 12th grade, equivalence of 12th grade, GED or having reached the age of 19 on or before September 1, whichever comes first.
4. 4-H membership is not dependent upon race, color, national origin, gender, religion, marital status, place of residence, or membership in any other organization.
5. Any individual who meets these requirements, properly completes 4-H enrollment online, and is listed as ACTIVE, is considered a bona fide 4-H member.
6. To be eligible to participate in any county based project area, 4-H members must have a complete and ACTIVE membership to participate. If no event specific membership requirement is posted, they must have a complete and ACTIVE membership 15 days prior to the posted event deadline to participate. Specific event participation eligibility guidelines take precedence.
7. Any person who has been barred from participation in a specific activity or event as a member of any other organization will not be eligible to represent their county as a 4-H member in that activity or event on a district or state-wide basis. (See Oklahoma 4-H Rules & Guidelines: Loss of Membership).

EXHIBITOR ELIGIBILITY

GUIDELINES CONCERNING EXHIBITION OF LIVESTOCK IN CANADIAN COUNTY

1. Once an exhibitor begins showing a livestock project in one organization he/she may not exhibit the same project in the other organization during the same academic year.
2. Exhibitors with more than one species of livestock will be allowed to show in both 4-H and FFA provided they have an FFA and 4-H Dual Membership Permissive Agreement completed and turned in to the Extension Center by December 1. (Ex.: An exhibitor may show one species of livestock in one organization and another separate species in the other organization.)
3. Any changes in project designation relating to organization must be done between the academic years (Summer Break).
4. 4-H members must have a complete and ACTIVE membership by February 2 to participate in the Spring County Livestock Show.

ACADEMIC ELIGIBILITY

1. Youth who have been declared ineligible to participate in extracurricular activities by their local school administration will be declared ineligible to participate in this show.
2. If an exhibitor is considered ineligible to participate in the show for any reason, including rules of the Oklahoma Secondary Schools Activity Association, (OSSAA), the animals owned by the exhibitor are also ineligible for the show.
3. Ineligible youth who participate in the show will forfeit all show and/or sales premiums and awards; and will be subject to disciplinary action as provided by the local school policies.
4. It will be the responsibility of the local school administration to notify the student's family and the show management or OSSAA if a particular student is ineligible to participate.



SHOWMANSHIP AWARD



Showmanship trophies will be presented to Junior, Intermediate and Senior winners in Beef, Swine, Sheep and Goat Divisions. Junior Division will be from 3rd-6th grade, Intermediate Division will be 7th-9th grade and Senior Division will be 10th-12th grade. Showmanship awards will be based on the following:

- (1) Appearance and response of animals exhibited.
- (2) Appearance and ability to exhibit in the show ring.
- (3) Courtesy in the ring to fellow exhibitors.

DOE GOAT RULES

- ♦ **All Doe Goats Self-Nominate through OYE**
- ♦ **Any breed or combination of Doe breeds may be shown.**
- ♦ **No registration paper requirement for Does.**
- ♦ **All Does will be weighed and divided into classes at superintendents' discretion with preferably no more than eight per class.**
- ♦ **Minimum weight 50-pounds and maximum weight limit 160– pounds.**
 - **No hair length rules**
 - **No tooth rule**
 - **No showing off trailers**
 - **Blow & Show Only**
- ♦ **Any goat with contagious diseases including ringworms must have health papers dated within 72-hours of weigh-in stating they are no longer contagious.**

MARKET BROILER RULES

Canadian County Jr. Livestock Show Entries are due February 2, 2024. Broilers MUST BE purchased through the Southwest District Livestock Show broiler program. SWDLS Entries and Broiler chick purchase declaration DUE NOVEMBER 28, 2023. There will be NO LATE ENTRIES!

General Rules and Guidelines:

1. Junior exhibitors are expected to adhere to the General Rules and Regulations, Show Ring code of Ethics and Animal Health Regulations.
2. All chicks will be purchased through the SWDLS. Purchase and Entry form must be turned into extension by November 28, 2023. All of the chicks will be hatched on or about Jan. 2, 2024 and they will be shipped Parcel Post, (United States Postal Service) directly to the extension office that day. Exhibitors should expect one to two day delivery.
3. Cost: Commercial Broiler-cross pullet chicks will be used at a cost of \$1.51 each. The minimum order is 25 chicks, at \$37.75 plus a \$25 show entry = \$62.75. That total is for the Southwest District Show ONLY. There is no entry fee for Canadian County Livestock Show.
4. Orders must be placed in multiples of 25. The maximum order is 25 chicks, (1 order) per contestant. (Show Entry fee is for Southwest District Show, you MUST PAY this entry to show at the County Jr. Livestock show in 2024.)
5. All chicks will be wing banded. All birds must have original wing band properly in place at the show. All Chicks and Wing bands will be inspected prior to exhibitor delivery.
6. All entries in this section will be subject to the Health Regulations governing the SWDLS except pullorum testing and health certificates. All Junior Market Broilers originated from a certified NPIP flock and are under 6 months of age, therefore, pullorum testing and health certificates are not required by the Oklahoma Department of Agriculture, Food and Forestry.
7. The owner/exhibitor is the person who ordered the birds. The broilers, from the time of delivery, must have been fed and cared for daily by the Junior Exhibitor. Siblings cannot share the birds.
8. Pens of broilers will be sifted. All entries must be of U.S. Grade A, live market quality, to be accepted. A pen may be sifted for the lack of uniformity. Each broiler must have the original wing band in place. After the broilers have been officially penned, they may not be handled by anyone except the judge and the youth handlers until all judging has been completed. Only pullets will be accepted.
9. Sick and/or diseased birds will not be accepted and if discovered during the show, will be removed from competition. Any bird with reduced comb growth or other secondary sex characteristics, which indicate the presence of a hormone, will be sifted. Sifted birds must be removed from the Exhibit Hall immediately, by the exhibitor.
10. Broilers will be assigned a small animal pen in the Canadian County Expo. Birds will be the responsibility of the exhibitor. All handling of birds by exhibitors after check-in is prohibited except as directed by the Superintendent.
11. Judging will be done according to U.S. Standards for live chickens. Placing will be made on the basis of market quality. Showing will require the youth exhibitor plus at least one other handler, preferably another youth. Non-youth handlers may be allowed if prior approval is obtained from the show superintendent.

GENERAL RULES OF LIVE & ONLINE PREMIUM AUCTION SALE

1. The 52nd Annual Live & Online Premium Auction Sale will be held at 6:00 PM on Friday, March 8, 2024, at Canadian County Expo Center & at www.kencarpenterauction.com
 2. The Fair Board Sale Committee named in this publication shall have complete jurisdiction over the sale and their decisions will be final in regard to matters or questions that may arise during the course of the show and sale.
 3. During the selection of animals for the sale the only individuals allowed to be in the ring will be the judge, exhibitors, superintendents and Auction Steering Committee members.
 4. **Exhibitors are allowed only one spot in the AUCTION SALE.**
 5. **3 Does, 5 Goats, 5 Ewes, 20 Wethers, 7 Gilts, 38 Barrows, 7 Heifers, 15 Steers, and 2 pen of 3 Broilers will be sold for a total of 102 Exhibitors.**
 6. Sale order will be determined immediately following the Grand Drive of that species. All animals called for Show Order must **show** when called. Sale order for broilers will only be Grand and Reserve Grand.
 7. The Grand Champion, Reserve Grand Champion, and Bronze Champion of the beef, swine, sheep and goat divisions, and broilers Grand and Reserve Grand are the only animals automatically eligible for the sale. All others will be shown for sale order and selected on quality. Breed Champion exhibits are not automatically in the sale.
 8. Once an exhibitor has an animal selected for sale, all other animals of that species owned by that exhibitor shall be scratched and are not eligible for sale order.
 9. **Exhibitor will sell their highest placing animal in the sale.** Tie break: if an exhibitor has more than one species qualify for the sale, the exhibitors' highest placing animal in that year's published sale order will determine that exhibitor's position in the sale. The species sale order rotates each year. In case an exhibitor has the same placement in their species market and breeding, the market animal will be placed in the sale.
- The sale order for 2024 will be Sheep, Swine, Beef, Broiler, & Goat.**
10. Check for premium sale and bonus will be mailed as soon as premiums are collected. Also, \$26 will be withheld for pictures.
